### **Organizational Changes**

Equity Sales - Institutional Investors Division (Change of name) Equity Sales Division is renamed Equity Sales - Institutional Investors Division.

(8) Financial Markets

Sales & Advisory for Wholesale Clients Division This is placed under joint management with Equity. (9) Corporate Planning (Change of name) Business & Strategic Planning is renamed Corporate Planning.

Communications Division (Transfer) Communications Division is transferred from General Management.

Retail Business is reorganized from the eight head offices to the five head offices.
