## NEW COLLATERAL RECOVERY UPDATE REQUIRED

Dear Petitioner:

I hope that this letter finds you and your loved ones safe and healthy during the current global struggles with the Coronavirus. The past six months have been traumatic for all of us. We hope that you have successfully navigated the health and living challenges of this new environment.

I am pleased to inform you that MVF is now preparing our sixth distribution ("D6") to victims of the Madoff fraud. We hope to be able to launch D6 before the end of the year. Our first five distributions have brought over 32,000 victims to a 73.65% recovery from all sources on their fraud losses. In addition to more than \$2.7 billion in cash payouts, we have also set aside substantial funds for victims who have not yet been able to disclose their collateral recoveries. Now, we are thrilled to be able to do more for our victims.

For D6, the U.S. Department of Justice will establish a new and higher target percentage. Your payment will be the target percentage of your approved fraud loss amount, less all prior recoveries from any source. MVF must have up to date information on your total recoveries in order to calculate your payment.

The table attached to this letter details what our records show you have recovered on your losses. Please add any new recoveries on your Madoff losses, and also correct any erroneous amounts. Please:
